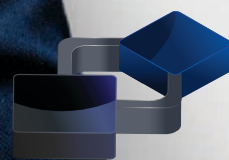

- Control supplier approvals by implementing automated digital and human review processes.
- Keep prospective suppliers informed on the progress of their application with automated email or SMS messages.

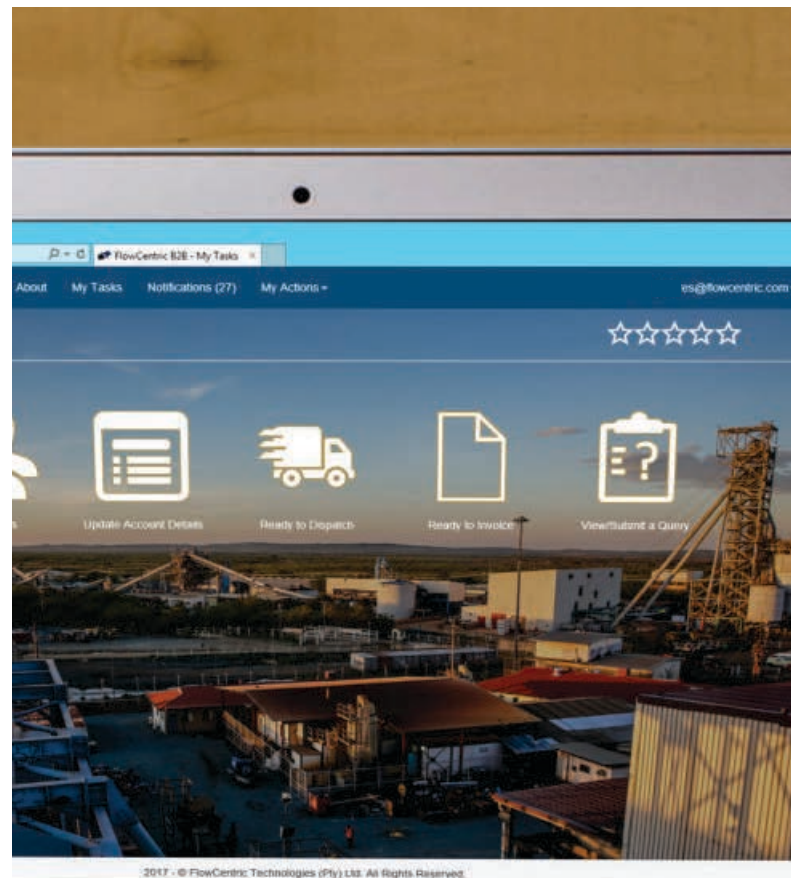
Once a supplier is onboarded the organisation can track the vendor's performance and any changes made to the vendor's information.

Stay on top of your data, stay compliant

Many businesses have hundreds of their supplier's personnel on premises at any given time. Numerous industries are heavily regulated, requiring employees to have up-to-date certifications in order to operate machinery, handle chemicals, and perform other critical functions. Organisations must ensure that their supplier's staff meet these requirements, before allowing the personnel on site, or face serious consequences. - Suppliers can upload copies of all their staff's certifications to the system for quick and easy reference.

- Integrate with your biometric system and deactivate access for users whose certificates have expired, thereby ensuring compliance.
- Notify suppliers via email or SMS of any additional certifications that may be mandatory.

Never miss a deadline

Promote inclusive bid management

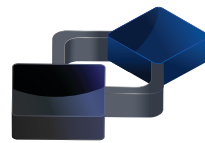

Benefits of Digitising Your Supplier Onboarding Process:

AUTOMATION: Free up resources to focus on more value-adding tasks.
